NTC MONEY WHEEL REQUIREMENTS

Each participant must meet ALL of the following requirements before they are given a chance to participate in the game.

- A.** If clients electronically file before February 1 they are still eligible to play game IF they meet ALL requirements.
- B.** Participant must have filed with any National Tax Centers participating location for at least 3 consecutive years. i.e. 2014, 2013, 2012
- C.** Participant must bring at least one NEW client that has not filed with any NTC Office location within the last year.
- D.** Participant agrees to FORFEIT his eligibility for the \$100 Referral buck or \$25 Referral buck for his/her new client.
- E.** Participant must have already electronically filed their tax return with NTC for the current tax year BEFORE playing the game.
- F.** Participant tax return must have an expected refund amount that is equal to or more than National Tax Center service fees.
- G.** Participant must have valid identification or driver's license
- H.** Participant must physically visit one of NTC participating locations
