Eligibility: You are automatically entered into the drawing when you file your taxes with any participating National Tax Centers location. You are given additional entries with the more customers you refer to any participating National Tax Centers location to increase your chances to win. All other entrants that do not file their taxes with any participating National Tax Centers location must mail on a postcard the participant's first and last name, resident address (no P.O. Boxes or mail centers), city, state, zip code, phone number and email address (if participant has an email address available).

By participating in the Promotion, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decision of the Sponsor which shall be final and binding in all respects. By participating in the promotion, participants agree to release, discharge, and hold harmless Sponsor and all other entities involved in and assisting with the Promotion, from any and all damages whether direct or indirect, which may be due to or arise out of participation in the Promotion or any portion thereof, or the acceptance and use/misuse of any prizes.
